#### Leadership & Administration

- Discussions of re-purposing GHCC funds during the NCE continued. Ultimately, it was decided that GHCC doesn't have the capacity to re-purpose and add deliverables.
- The Partnership Health Survey was sent out for GHCC team input. Thank you. We have received 8 responses so far.
- Devon is collecting information regarding the team's other cost Studies and external meetings attended.

#### Standards & Methods

- The 49<sup>th</sup> International Union Against Lung Disease and Tuberculosis Meeting took place at the Hague at the end of October 2018.
  - Gaby taught a post graduate course on TB modelling and cost effectiveness. She introduced GHCC and its tools to the participants.
  - Anna, Sedona, Edina and Lori taught post-graduate course titled "An introduction to costing tuberculosis services", introducing GHCC and its tools (Reference case and UCSR).
- Gaby presented on economics of new TB treatment at the INTERTB workshop in London 22nd October 2018.
  - Stakeholders interested in advancing research in TB treatment attended.
    - Included trialists, pharma (GSK, Janssen), NGO like the Global Alliance for TB drug development, some economists (Bertie Squire from LSTM), and implementation science researchers.
  - Gaby introduced GHCC and its tools. There was some interest from GSK and Bertie (to see how it progresses).
- Mariana passed over the healthcare provider cost database to UCT to write the HS cost paper.
- Challenges:
  - There was a lot of back and forth between Willyanne and Mariana regarding form and column heading changes.
  - November 2018 through July 2019 Marina is down to 30% and Gaby is down 10%, will need to focus on finalizing ongoing deliverables.

#### Data & Analytics

- Quality assurance on all interventions has been completed.
- Quality assurance edits have been implemented for all interventions.
- Quality rating is underway.
- Pilot emails were sent to request feedback from UCSR authors and we received some.
- Weekly meetings will change to bi-weekly soon.

#### Advocacy & Communication

• The 3rd quarter GHCC external newsletter was written, collated, and sent out (2018 October 22)
